

ORDINANCE NO. 577

AN ORDINANCE OF THE CITY OF PRIEST RIVER, BONNER COUNTY, IDAHO, AMENDING ORDINANCE NO. 567, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2014 AND ENDING SEPTEMBER 30, 2015, APPROPRIATING ADDITIONAL MONIES RECEIVED IN THE STREET FUND IN THE SUM OF \$31,900.00; FURTHER ALLOWING FOR THE TRANSFER OF RESERVE FUNDS IN THE SUM OF \$140,000.00 FOR THE STREET FUND; DIRECTING THE CITY CLERK TO FILE A CERTIFIED COPY OF THIS ORDINANCE WITH THE IDAHO SECRETARY OF STATE; AND PROVIDING FOR AN EFFECTIVE DATE.

Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:

SECTION I: That Ordinance No. 567, the Appropriations Ordinance for the City of Priest River, Idaho, for the fiscal year commencing October 1, 2014 and ending September 30, 2015, be, and the same is hereby amended as follows:

That an additional sum of **\$31,900.00** be appropriated out of additional revenues received from the Street Fund to be used for authorized activities, and an additional sum of **\$140,000.00** be transferred from the City of Priest River's reserve account designated for street maintenance and repairs be appropriated in the Street Fund.

That said same sum be authorized for expenditure.

SECTION II: This Ordinance shall be in full force and effect from and after its passage, approval, and publication.

SECTION III: The City Clerk of the City of Priest River is hereby directed to file a certified copy of this Ordinance with the Idaho Secretary of State, in accordance with Idaho Code 50-1003.

SECTION IV: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION V: This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Priest River Times, a newspaper of general circulation in the City of Priest River, and the official newspaper of said City.
