

**ORDINANCE NO. 623**

**AN ORDINANCE OF THE CITY OF PRIEST RIVER, BONNER COUNTY, IDAHO, AMENDING ORDINANCE NO. 613, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021, ALLOWING AND APPROPRIATING INTERIM FINANCING LOAN FUNDS AND IDAHO COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS IN THE AMOUNT OF \$400,000.00, DESIGNATED FOR THE WATER SYSTEM IMPROVEMENT PROJECT; DIRECTING THE CITY CLERK TO FILE A CERTIFIED COPY OF THIS ORDINANCE WITH THE IDAHO SECRETARY OF STATE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:**

**SECTION I:** That Ordinance No. 613, the Appropriations Ordinance for the City of Priest River, Idaho, for the fiscal year commencing October 1, 2020 and ending September 30, 2021, be, and the same is hereby amended as follows:

That an additional amount of \$400,000.00 be appropriated out of the revenues from Interim Financing Loan funds and Idaho Community Development Block Grant funds in the sum of \$400,000.00, to be used for authorized activities in the Water Fund.

a newspaper of general circulation in the City of Priest River, and the official newspaper of said City.


