## **ORDINANCE NO. 641**

AN ORDINANCE OF THE CITY OF PRIEST RIVER, BONNER COUNTY, IDAHO, AMENDING ORDINANCE NO. 637, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025, ALLOWING AND APPROPRIATING AN ADDITIONAL \$154,000.00 IN THE WATER FUND AND AN ADDITIONAL \$5,000.00 IN THE SEWER FUND; DESIGNATING THE USE OF THE ADDITIONAL FUNDS TOWARDS SPECIFIC PROJECTS; DIRECTING THE CITY CLERK TO FILE A CERTIFIED COPY OF THIS ORDINANCE WITH THE IDAHO SECRETARY OF STATE; AND PROVIDING FOR AN EFFECTIVE DATE.

Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:

**SECTION I:** That Ordinance No. 637, the Appropriations Ordinance for the City of Priest River, Idaho, for the fiscal year commencing October 1, 2024 and ending September 30, 2025, be, and the same is hereby amended as follows:

That an additional amount of \$154,000.00 be appropriated from a water meter replacement reserve fund transfer of \$17,945.00 and a water capital reserve fund transfer of \$136,055.00, to be used towards the Meter Replacement Project and the Larch Street Waterline Replacement Project. That an additional amount of \$5,000.00 be appropriated from a sewer capital reserve fund transfer of \$5,000.00, to be used towards the Sludge Bin Roof Project at the Sewer Treatment Plant.
